**Being a By-law to Appoint Temporary Municipal Law Enforcement Officers  
for the 2025 Summer Season**

---

**Whereas** section 15 of the *Police Services Act*, R.S.O. 1990, c. P.15, provides that a municipal council may appoint persons to enforce the by-laws of the municipality and that municipal law enforcement officers are peace officers for the purpose of enforcing municipal bylaws; and

**Whereas** section 101 of the *Municipal Act*, 2001, S.O. 2001, c. 25, provides that a municipal law enforcement officer may provide evidence and the impoundment of parked vehicles; and

**Whereas** it is deemed desirable to appoint temporary Municipal Law Enforcement Officers for the 2025 summer season;

**Now, therefore**, the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

1. **That** each of the following persons is appointed a temporary Municipal Law Enforcement Officer for The Corporation of the Town of Fort Erie and is also appointed a temporary Provincial Offences Officer while in the discharge of their duties until on or about September 30, 2025, or as may be extended by the Chief Administrative Officer:
  - i. Cody Willard;
  - ii. Connor Connaughton;
  - iii. Zayne Dehghan; and
  - iv. Joel Coopman
2. **That** the Clerk of the Town is authorized to affect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

Read a first, second and third time and finally passed this 12th day of May 2025.

**By-law 45-2025**

**Being a By-law to Confirm the Actions of Council at its  
Special Council Meeting Held May 12, 2025**

---

**Whereas** it is desirable to have the actions and proceedings of Council adopted, ratified and confirmed by by-law; and

**Now, therefore,** the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

1. **That** the actions of Council at its Special Council Meeting held on May 12, 2025, including all motions, resolutions and other actions, are adopted, ratified and confirmed as if they were expressly embodied in this by-law, except where the law requires the prior approval of any authority.
2. **That** where no individual by-law has been or is passed with respect to the taking of any action authorized in or with respect to the exercise of any powers by the Council, then this by-law is deemed for all purposes to be the by-law required for such authorization or exercise of any powers.
3. **That** the Mayor and officers of The Corporation of the Town of Fort Erie are authorized and directed to do all things necessary to give effect to such actions or to obtain approvals where required.
4. **That** except where otherwise provided, the Mayor and the Clerk are authorized and directed to execute all documents arising from such actions.
5. **That** the Clerk of the Town is authorized to affect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

Read a first, second and third time and finally passed this 12th day of May 2025.
