5. Purpose of Report

The purpose of this report is to provide Council with the 2025 operating budget for the Fort Erie Public Library Board that will be presented by the Board and Library staff on January 29, 2025. The grant request will be considered as part of the General Levy Operating Budget.

6. Analysis

The Library base budget grant request as approved by the Library Board is \$1,702,699 and is summarized in Appendix 1. This is a \$55,081 or 3.3% increase over the 2024 grant and represents 5.0% of the Town's General Levy.

The request is \$16,881 higher than the 2025 forecast used in the analysis of the 2025 Budget Planning Report <u>CS-07-2024</u>. The detailed Library budget is provided for Council review in Tab 9 of Council's budget package.

7. Financial, Staffing and Accessibility (AODA) Implications

The following is a summary of the net levy impact of the 2025 base budget request:

The base budget request of \$1,702,699 is increased by the capital contribution of \$39,600 from the Development Charges Reserve for material and furnishings and is reduced by information technology and insurance services provided by and retained by the Town in the amount of \$50,012 for a total payment of \$1,692,287. The base budget forecast periods are proposed to increase 4.9% in 2026 to \$1,786,286 and 3.6% in 2027 to \$1,850,245.

8. Policies Affecting Proposal

By-law <u>136-2023</u> adopted Council's 2023-2026 Corporate Strategic Plan.

By-law 127-09, as amended, adopted the Budget Policy.

9. Comments from Departments, Community and Corporate Partners

The Library Board approved the 2025 Budget request at their December 3, 2024 meeting. Library staff will make a presentation to Council on January 29, 2025.

10. Alternatives

Council may wish to approve an amount different than what was requested by the Library Board.

11.Communicating Results

Information about the 2025 Library Budget will be communicated to residents together with the General Levy Budget media release and updates on social media. The information may be added in the Town's e-Newsletter and on the website.

12.Conclusion

That the attached 2025 Operating Budget and Forecast Library budget be included in the Town's consolidated 2025 Operating Budget to be considered January 29, 2025.
